#### **Additional Terms and Conditions:**

- 01. All terms and conditions applicable to Medical Officer services of ICAR will apply.
- 02. No TA/DA will be provided for attending the interview.
- 03. The position is purely contractual for an initial term of one year, effective from the joining date. Future extensions are strictly subject to satisfactory performance, continued eligibility, and approval by the competent authority. The candidate will have no right to claim regular employment at this institute based on this contract.
- 04. The Medical Officer will be responsible for treating the employees, their dependants and students of the Institute, including prescribing medicines for common diseases.
- 05. He/She will be required to strictly follow the CS (MA) Rules, 1944, and related orders issued from time to time.
- 06. The Medical Officer is required to countersign records maintained at the Dispensary (e.g., Out Patient register, stock registers).
- 07. For any leave or absence, the Medical Officer must inform the Institute in advance. The Institute may deduct pro-rata remuneration for such periods of absence.
- 08. The Competent Authority, ICAR-IARI Jharkhand, reserves the right to accept or reject any application and to terminate the contractual engagement at any time, even before the tenure expiry, without assigning any reason. The decision of the Competent Authority will be final.
